In accordance with the provisions of Chapter 90, Section 18, of the General Laws (Ter. Ed.) as amended, the following Special Speed Regulation is

hereby Adopted

by the Board of Selectmen

of the Town of South Hadley

That the following speed limits are established at which motor vehicles may be operated in the areas described:

Mary Lyon Drive - Northbound

Beginning at Granby town line, thence northerly on Mary Lyon Drive

0.41 miles at 25 miles per hour ending at Morgan Street, the total distance being 0.41 miles.

Mary Lyon Drive - Southbound

Beginning at Morgan Street, thence southerly on Mary Lyon Drive

0.41 miles at 25 miles per hour ending at the Granby town line, the total distance being 0.41 miles.

Virginia Drive - Northbound

Beginning at Mary Lyon Drive (south), thence northerly on Virginia Drive

0.28 miles at 25 miles per hour ending at Mary Lyon Drive (North), the total distance being 0.28 miles.

Virginia Drive - Southbound

Beginning at Mary Lyon Drive (north) thence southerly on Virginia Drive

0.28 miles at 25 miles per hour ending at Mary Lyon Drive (south), the total distance being 0.28 miles.

Lamb Street (Rte. 116) - Northbound

Beginning at So. Main Street, thence northerly on Lamb Street

0.35 miles at 25 miles per hour

0.12 " " 30 " " " ending at the beginning of State highway, the total distance being 0.47 miles.

Lamb Street (Rte. 116) - Southbound

Beginning at the end of State Highway, thence southerly on Lamb Street

0.12 miles at 30 miles per hour 0.37 " " 25 " " " ending at So. Main Street, the total distance being 0.49 miles.

Operation of a motor vehicle at a rate of speed in excess of these limits shall be prima facie evidence that such speed is greater than is reasonable and proper.

The provisions of this regulation shall not, however, abrogate in any sense Chapter 90, Section 14, of the General Laws (Ter. Ed.).
