Highway Location: WESTFIELD
Authority In Control: CITY OF WESTFIELD
Name of Highways: Pleasant Street, South Maple Street and Southwick Road

In accordance with the provisions of Chapter 90, Section 18, of the General Laws (Ter. Ed.) as smended, the following Special Speed Regulation is Hereby Adopted

By the City Council
Of the City of Westfield

That the following speed limits are established at which motor vehicles may be operated in the areas described:

PLEASANT STREET - SOUTHBOUND

Beginning at Court Street
Thence southerly on Pleasant Street
0.37 miles at 25 miles per hour ending at West Silver Street; the total distance being 0.37 miles.

PLEASANT STREET - NORTHBOUND

Beginning at West Silver Street
Thence northerly on Pleasant Street
0.37 miles at 25 miles per hour ending at Court Street; the total distance being 0.37 miles.

SOUTH MAPLE STREET - SOUTHBOUND

Beginning at West Silver Street
Thence southerly on South Maple Street
0.25 miles at 25 miles per hour
0.47 " " 30 " " " ending at Southwick Road; the total distance being 0.72 miles.

SOUTH MAPLE STREET - NORTHBOUND

Beginning at Southwick Road
Thence northerly on South Maple Street
0.47 miles at 30 miles per hour
0.25 " " 25 " " " ending at West Silver Street; the total distance being 0.72 miles.

SOUTHWICK ROAD - SOUTHBOUND

Beginning at South Maple Street
Thence southerly on Southwick Road
0.26 miles at 30 miles per hour
1.25 " " 40 " " " ending at the Westfield -
Southwick Town Line; the total distance being 1.51 miles.

SOUTHWICK ROAD - NORTHBOUND

Beginning at the Southwick - Westfield Town Line
Thence northerly on Southwick Road
1.25 miles at 40 miles per hour
0.26 " " 30 " " " ending at South Maple Street;
the total distance being 1.51 miles.

Operation of a motor vehicle at a rate of speed in excess of these limits shall be prima facie evidence that such speed is greater than is reasonable and proper.

The provisions of this regulation shall not, however, abrogate in any sense Chapter 90, Section 14, of the General Laws (Ter. Ed.)
