hereby Adopted

by the Board of Selectmen

of the Town of Swampscott

That the following speed limits are established at which motor vehicles may be operated in the areas described:

PLEASANT STREET-NORTHBOUND

Beginning at the junction of Humphrey Street
Thence northerly 0.25 miles at 25 miles per hour ending at the junction
of Sargent Road.

PLEASANT STREET-SOUTHBOUND

Beginning at the junction of Sargent Road Thence southerly 0.25 miles at 25 miles per hour ending at the junction of Humphrey Street.

FOREST AVENUE-EASTBOUND

Beginning at the junction of Devens Road and Redington Street Thence easterly 0.07 miles at 20 miles per hour

FOREST AVENUE-WESTBOUND

Beginning at the junction of Laurel Road Thence westerly 0.19 miles at 25 miles per hour

LAUREL ROAD-NORTHBOUND

Beginning at the junction of Forest Avenue Thence northerly 0.12 miles at 25 miles per hour ending at the junction of Nason Road.

LAUREL ROAD-SOUTHBOUND

Beginning at the junction of Nason Road Thence southerly 0.12 miles at 25 miles per hour ending at the junction of Forest Avenue.

NASON ROAD-EASTBOUND

Beginning at the junction of Laurel Road Thence easterly 0.26 miles at 30 miles per hour ending at the junction of Neighborhood Road.

NASON ROAD-WESTBOUND

Beginning at the junction of Neighborhood Road
Thence westerly 0.26 miles at 30 miles per hour ending at the junction of Laurel Road.

ORCHARD ROAD-NORTHBOUND

Beginning at the junction of Humphrey Street
Thence northerly 0.19 miles at 25 miles per hour ending at the junction
of Nason Road.

ORCHARD ROAD-SOUTHBOUND

Beginning at the junction of Nason Road Thence southerly 0.19 miles at 25 miles per hour ending at the junction of Humphrey Street.

ORCHARD CIRCLE-EASTBOUND

Beginning at the junction of Orchard Road Thence easterly 0.13 miles at 25 miles per hour ending at the junction of Humphrey Street.

ORCHARD CIRCLE-WESTBOUND

Beginning at the junction of Humphrey Street
Thence westerly 0.13 miles at 25 miles per hour ending at the junction
of Orchard Road.

BANKS ROAD-EASTBOUND

Beginning at the junction of Farragut Road Thence easterly 0.27 miles at 20 miles per hour ending at the junction of Devens Road and Redington Street.

BANKS ROAD-WESTBOUND

Beginning at the junction of Redington Street and Forest Avenue Thence westerly 0.27 miles at 20 miles per hour ending at the junction of Farragut Road.

REDINGTON STREET-NORTHBOUND

Beginning at the junction of Humphrey Street
Thence northerly 0.38 miles at 25 miles per hour ending at the junction
of Devens Road and Banks Road.

REDINGTON STREET-SOUTHBOUND

Beginning at the junction of Banks Road and Devens Road Thence southerly 0.38 miles at 25 miles per hour ending at the junction of Humphrey Street.

Operation of a motor vehicle at a rate of speed in excess of these limits shall be prima facie evidence evidence that such speed is greater than is reasonable and proper.

The provisions of this regulation shall not, however, abrogate in any sense Chapter 90, Section 14, of the General Laws (Ter. Ed).
