In accordance with the provisions of Chapter 90, Section 18 of the General Laws (Ter. Ed.) as amended, the following Special Speed Regulation is

hereby Adopted

by the Board of Selectmen

of the Town of Stockbridge

That the following speed limits are established at which motor vehicles may be operated in the areas described:

#### PINE STREET - NORTHBOUND

Beginning at Main Street
Thence northerly on Pine Street
0.38 miles at 25 miles per hour ending at Vine Street;
The total distance being 0.38 miles.

### PINE STREET - SOUTHBOUND

Beginning at Vine Street
Thence southerly on Pine Street
0.38 miles at 25 miles per hour ending at Main Street;
The total distance being 0.38 miles

## PROSPECT HILL ROAD - NORTHBOUND

Beginning at Pine Street
Thence northerly on Prospect Hill Road

0.43 miles at 30 miles per hour

0.92 " " 35 " " ending at Route I-90

(Turnpike); The total distance being 1.35 miles.

## PROSPECT HILL ROAD - SOUTHBOUND

Beginning at Route I-90 (Turnpike)
Thence southerly on Prospect Hill Road

0.92 miles at 35 miles per hour

0.43 " " 30 " " " ending at Pine Street;
The total distance being 1.35 miles.

## MAHKEENAC ROAD - NORTHBOUND

Beginning at Route 90 (Turnpike) Thence northerly on Mahkeenac Road

3.21 miles at 35 miles per hour

" ending at West Hawthorne 30 Road; The total distance being 3.25 miles.

#### MAHKEENAC ROAD - SOUTHBOUND

Beginning at West Hawthorne Road Thence southerly on Mahkeenac Road

3.25 miles at 35 miles per hour ending at Route I-90 (Turnpike); The total distance being 3.25 miles.

## WEST HAWTHORNE ROAD - NORTHBOUND

Beginning 100 feet north of Mahkeenac Road Thence northerly on West Hawthorne Road 0.73 miles at 30 miles per hour ending at Route 183; The total distance being 0.73 miles.

## WEST HAWTHORNE ROAD - SOUTHBOUND

Beginning at Route 183

Trance southerly on West Hawthorne Road

0.75 miles at 30 miles per hour ending at Mahkeenac Road; The total distance being 0.75 miles.

Operation of a motor vehicle at a rate of speed in excess of these limits shall be prima facie evidence that such speed is greater than is reasonable and proper.

The provisions of this regulation shall not, however, abrogate in any sense Chapter 90, Section 14 of the General Laws (Ter. Ed.)
