In accordance with the provisions of Chapter 90, Section 18, of the General Laws (Ter. Ed.) as amended, the following Special Speed Regulation is

hereby Adopted

by the Traffic Commission

of the City of Malden

That the following speed limits are established at which motor vehicles may be operated in the areas described:

Broadway - Northbound

Beginning at the Everett-Malden city line Thence northerly on Broadway

0.44 miles at 35 miles per hour

0.61 " " 30 "

" " ending at the beginning 0.54 " " 35

of State Highway, the total distance being 1.59 miles.

Broadway - Southbound

Beginning at the end of State Highway Thence southerly on Broadway

0.54 miles at 35 miles per hour

0.61 " " 30 " " "

0.44 " " 35 " " ending at the

Malden-Everett city line, the total distance being 1.59 miles.

Main Street - Northbound

Beginning at the Everett-Malden city line, Thence northerly on Main Street

0.54 miles at 30 miles per hour

0.44 " " 25 " " "

0.52 " " 30 " " "

0.35 " " 35 " " ending at the Melrose-

Malden city line, the total distance being 1.85 miles.

Main Street - Southbound

Beginning at the Melrose-Malden city line, Thence southerly on Main Street

0.35 miles at 35 miles per hour

0.52 " " 30 " " "

0.44 " " 25 " "

0.54 " " 30 " " ending at the Everett-

Malden city line, the total distance being 1.85 miles.

Operation of a motor vehicle at a rate of speed in excess of these limits shall be prima facie evidence that such speed is greater than is reasonable and proper.

The provisions of this regulation shall not, however, abrogate in any sense Chapter 90, Section 14, of the General Laws (Ter. Ed.).
