Name of Highway (s): INTERSTATE ROUTE 190

In accordance with the provisions of Chapter 90, Section 18, of the General Laws (Ter. Ed.) as amended, the following Special Speed Regulation is hereby promulgated:

Special Speed Regulation number 6015-A dated January 13, 1983 is hereby amended by striking out the regulation in its entirety and inserting in place thereof the following revision and addenda.

That the following speed limits are established at which motor vehicles may be operated in the areas described:

NORTHBOUND

Beginning in Worcester at Station 38+00, thence northerly on Interstate Route 190;

2.94 miles at 65 miles per hour to the West Boylston Town Line.

Thence northerly in West Boylston;

1.07 miles at 65 miles per hour to the Holden Town Line.

Thence northerly in Holden;

2.50 miles at 65 miles per hour to the West Boylston Town Line.

Thence northerly in West Boylston;

1.76 miles at 65 miles per hour to the Sterling Town Line.

Thence northerly in Sterling;

6.65 miles at 65 miles per hour to the Lancaster Town Line.

Thence northerly in Lancaster;

2.11 miles at 65 miles per hour to the Leominster Town Line.

Thence northerly in Leominster;

0.54 miles at 65 miles per hour

0.78 miles at 55 miles per hour ending at Station 656+00, the total distance being 18.35 miles.

SOUTHBOUND

Beginning in Leominster at Station 680+00, thence southerly in Leominster;

0.87 miles at 55 miles per hour

1.04 miles at 65 miles per hour to the Lancaster Town Line.

Thence southerly in Lancaster;

1.97 miles at 65 miles per hour to the Sterling Town Line.

Thence southerly in Sterling;

6.65 miles at 65 miles per hour to the West Boylston Town Line.

Thence southerly in West Boylston;

1.66 miles at 65 miles per hour to the Holden Town Line.

Thence southerly in Holden;

2.63 miles at 65 miles per hour to the West Boylston Town Line.

Thence southerly in West Boylston;

1.07 miles at 65 miles per hour to the Worcester City Line.

Thence southerly in Worcester;

2.78 miles at 65 miles per hour

0.28 miles at 45 miles per hour ending at Station 32+00; the total distance being 18.96 miles.

Operation of a motor vehicle at a rate of speed in excess of these limits shall be prima facie evidence that such speed is greater than is reasonable and proper.

The provisions of this regulation shall not, however, abrogate in any sense Chapter 90, Section 14, of the General Laws (Ter. Ed.).

The Highway Department and the Registry of Motor Vehicles, acting jointly, do hereby certify that this regulation is consistent with the public interest.

Standard signs must be erected at the beginning of each zone.
