Name of Highway (s): SUNDERLAND -STATE HIGHWAY-ROUTE 116

In accordance with the provisions of Chapter 90, Section 18, of the General Laws (Ter. Ed.) as amended, the following Special Speed Regulation is hereby promulgated:

Special Speed Regulation number 731-C, dated January 13, 1981 is hereby amended in the Town of Sunderland as follows:

That the following speed limits are established at which motor vehicles may be operated in the areas described:

SUNDERLAND - ROUTE 116 - NORTHBOUND

By striking out the clauses reading:
1.25 miles at 45 miles per hour
0.56 miles at 50 miles per hour

And inserting in place thereof:
0.55 miles at 45 miles per hour
0.69 miles at 40 miles per hour
0.57 miles at 50 miles per hour

SUNDERLAND - ROUTE 116 - SOUTHBOUND

By striking out the clauses reading:
0.56 miles at 50 miles per hour
1.25 miles at 45 miles per hour

And inserting in place thereof:
0.57 miles at 50 miles per hour
0.69 miles at 40 miles per hour
0.55 miles at 45 miles per hour

Operation of a motor vehicle at a rate of speed in excess of these limits shall be prima facie evidence that such speed is greater than is reasonable and proper.

The provisions of this regulation shall not, however, abrogate in any sense Chapter 90, Section 14, of the General Laws (Ter. Ed.).

The Highway Department and the Registry of Motor Vehicles, acting jointly, do hereby certify that this regulation is consistent with the public interest.

Standard signs must be erected at the beginning of each zone.
