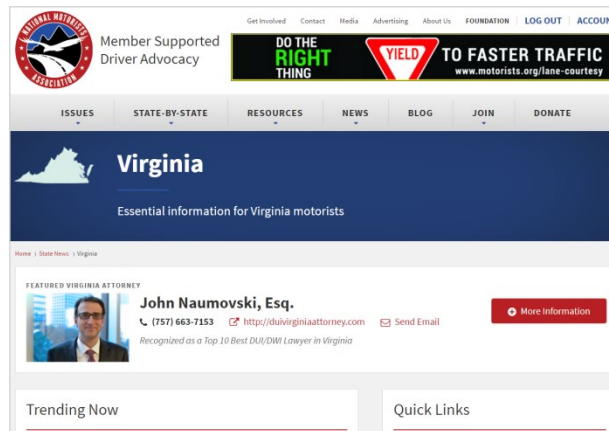

### State Page Rotating Banner (1140p x 300p)

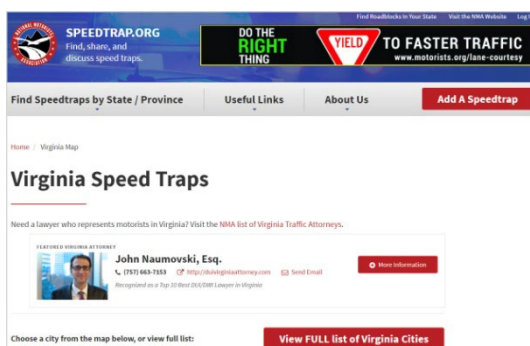
A focal point of all three sites are the state pages. They draw a high volume of regular traffic – Motorists.org with daily driving news stories, featured posts, and forum discussions; Speedtrap.org and Roadblock.org with driver-sourced reporting on specific community-based enforcement actions. 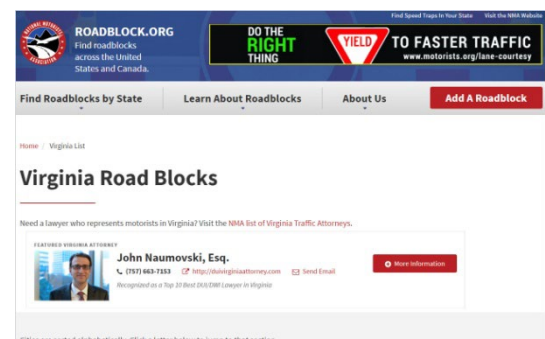

### **State Page Rotating Banner, 1140p x 300p**

Discounted Monthly Rate	<u>\$ 39.13</u>
